

"Hertz Gold Karting " Sweepstakes Official Rules

DATES OF SWEEPSTAKES: The "Hertz Gold Karting Sweepstakes" (the "Sweepstakes") begins at 12:00:01 a.m. Eastern Time ("ET") on August 26, 2025 and ends at 11:59:59 p.m. ET on September 3, 2025 (the "Sweepstakes Period").

ELIGIBILITY: The Sweepstakes is open to legal United States residents residing in the forty-eight (48) contiguous United States and the District of Columbia, except New York, Florida, Tennessee and Rhode Island who are at least twenty one (21) years of age or older, a Hertz Gold Rewards member, and possess a valid driver's license at the time of entry (each, an "Entrant"). Hertz Gold Plus Rewards Membership is free. Upon clicking the "Enter" button, Entrants will receive one (1) entry into the Sweepstakes. Entrant must submit the Entry Form by 11:59 p.m. ET on September 3, 2025 to receive an entry.

An Entrant may also sign up to be on the waiting list and/or participate in an Open Track session (subject to space availability).

PRIZE: Each winner will participate as part of a COTA Go Kart racing team in a 3 hour endurance race at the COTA Go Kart Racing facility in Del Valle, Texas on September 6, 2025 ("Race"). Team members may also receive customized team merchandise. Approximate retail value of prize is \$15,513.00. Winning team members will receive a guided tour of the racing facility and garage and behind the scenes access and may also receive additional merchandise selected by Sponsor in its sole discretion.

Winners must agree to be present for and participate in the Race at the time specified in notifications. Winners are responsible for all costs, including travel costs, associated with attending the Race. Winners must comply with all Race and COTA facility rules. Winners must bring a valid driver's license and meet be in good health and meet and comply with all COTA safety and other requirements to participate. COTA may require Winners and other drivers to sign releases in order to drive.
